Joseph Has a Cozy Home this Winter Because You Care

Winters in the Midwest can be brutal, especially for someone experiencing homelessness. When that person is also contending with physical disabilities (including difficulty with verbal and written communication) resulting from a stroke, the situation can be life-threatening. Fortunately for Joseph*, a referral to LSS Gaining Ground helped him find safe, sustainable housing and connected him to resources that foster his independence.

When LSS Gaining Ground colleague Matthew
Koski first met Joseph, he admits it was like playing
charades. "He is cognitively sharp, but he just
can't find words much beyond yes or no," Matthew
explains. "He's been dealing with this condition,
expressive aphasia, for nearly 10 years, so he's
found ways to communicate, but at the beginning
there was a lot of trial and error."

Joseph's first goal was to find housing. Matthew helped him navigate the application process and secure an apartment in a local subsidized housing complex. Next, Matthew helped Joseph navigate community resources that connected him with doctors for pain management and to obtain a new



prescription for eyeglasses and a lift chair. "He had a big smile on his face when he realized the difference that chair makes," Matthew said.

Perhaps the most life-changing resource Matthew was able to help Joseph obtain is a communication app on his tablet specifically for people experiencing expressive aphasia. Installed by an occupational therapist, the app helps facilitate conversations between Joseph and other people.
